The objective of this PPI project is to improve the pharmacotherapeutic process of patients who are dispensing drugs from the Outpatient Pharmaceutical Care Unit (UAF-PEX) of the University Hospital Miguel Servet of Zaragoza (HUMS) through the use of new technologies.
